1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. **The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.**
- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in “**Quotation Box**” located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
- Firm shall be registered with the Government of Rajasthan / Central Government.
 - The firm shall have valid GST No.
 - **The firm should not be black listed by any Govt. Agency/Dept.**
- J) Quotations qualified by such vague and indefinite expressions such as “subject to prior

confirmation”, “subject to immediate acceptance” etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.

- K) **Delivery Period** – within 30 days from Purchase order.
- L) **Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
- M) **Payment Terms:** Payment will be only after satisfactorily delivery / commissioning of material and after inspection by the AIIMS Jodhpur.
- N) **Disputes:** -In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Jodhpur with regards to the interpretation of “Terms & Conditions” of this inquiry, the same shall be referred to the Director, AIIMS Jodhpur whose decision will be final and binding upon the contractor.
- O) AIIMS, Jodhpur reserves the right to increase or decrease quantity and / or amount of work. Decision of Quantity of material in the AIIMS, Jodhpur will be final in this regard.
- P) AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.

1.	Artificial Skeleton	<ul style="list-style-type: none"> • The Adult Human skeleton should be designed as visual aid for teaching physiology and hygiene courses. It should help the students to understand the relationship between human body figure and skeleton. It can also be used for studying the morphology of bones and the construction of joints. • This adult make skeleton in size 180cms made of PVC plastic should be in a set-in standing posture. The joints of the upper and lower extremities should be moveable. • The Skull of this skeleton should be composed of twenty-two pieces of bones with serrated sutures lines marked out. Caldarium should be transversely out to show the interior structures of the skull. Mandible should be movable, three lower teeth-incisor, cusped and molar should be removable. • The vertebral column of this skeleton should be composed of seven cervical vertebrae, twelve thoracic vertebrae and five lumbar vertebrae, a piece of sacrum, a piece of coccyx and twenty-three intervertebral discs. The vertebral column should show four curvatures i.e., cervical and lumbar curvatures, being convex forward, thoracic and sacral curvature, being convex backward • The bony thorax of this skeleton should be composed of twenty-four ribs, a piece of costal cartilages and a piece of sternum. it should include seven pairs of true of true ribs, three pairs of false ribs and two of floating ribs. The bony pelvis of this skeleton should be composed of sacrum, coccyx and two pieces of hip bones. • The bones of upper extremities should be composed of sixty – four pieces of separable bones. The pectoral girdle (scapula and clavicle) should be fixed on the bony thorax, the remaining parts of the upper extremities can be taken down. The main joints shoulder, elbow and wrist should be movable. • The bones of lower extremities should be composed of sixty-two pieces of separable bones. The pelvis girdle hip bone should be fixed to construct the bony pelvis. The remaining pars of the lower extremities can be taken down. The main joints hip, knee and ankle should be should be removable. This skeleton should have a hanging facility and should be mounted on a sturdy movable stand. 	02 Nos.
