Sealed Quotations are hereby invited by the undersigned on behalf of the Executive Director, AIIMS, Jodhpur for Auction of Scrap Batteries, at AIIMS, Jodhpur. Interested bidders who meet the pre-qualification criteria may fill their quotation along with all the required documents and drop in "Quotation Box" located in Administration Block of AIIMS, Jodhpur, on or before **16th April 2024 up to 03:00 PM**. The Envelope containing the quotation would be sealed and super scribed as under: -

General Terms and Conditions:

1. The quotations received after **16.04.2024** or unsealed shall not be entertained under any circumstances whatsoever. ***In case of postal delay, this Institute will not be responsible.*** The offer Submitted by/through Fax/Email shall not be considered and no correspondence will be entertained in this matter.
2. **Only those agencies/firm who have permission for collection, disposal, storage of hazardous waste/scrap batteries as per the guidelines from Ministry of Environment & Forest by the concerned Central or State Pollution Control Board are eligible to quote/submit the offer.**
3. Quotations must be in the enclosed prescribed format duly signed by the Proprietor/Partner/Director of the firm/vendor or their Authorized Representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in the Administration Block of AIIMS, Jodhpur. Quotation must be in a sealed envelope super scribed with inquiry number.
4. Rates must be quoted in "Indian Rupees" and quotation should give rates, showing taxes, levies, if any. Quotations not confirming to these requirements shall be rejected and no correspondence will be entertained whatsoever.
5. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
6. The rates quoted must be valid for 90 days minimum from the date of opening of the quotation.
7. Bidders must quote rate in Price Bid Form provided in **Annexure-A** on the letterhead of the firm.
8. Quotation form shall be filled neatly and accurately. Incomplete quotation not confirming strictly in the prescribed manner shall not be considered and shall be summarily rejected.
9. Conditional quotation will be summarily rejected.
10. Quotations qualified by such vague and indefinite expressions such as "subject to prior confirmation", "subject to immediate acceptance" etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
11. The successful bidder must submit the full quoted amount within **seven (07) days** to the Institute from the date of issue of Award Letter.
12. Only after depositing the full amount, the successful bidder shall be allowed to lift/take away the auctioned material in presence of Engineer in-charge within **Fifteen (15) days** of issue of Award Letter.
13. The quotation document is non-transferable.
14. Bidders submitting the bid would be considered to have accepted all the terms & conditions. No inquiry verbal or written shall be entertained in acceptance or rejections of the bid.
15. **Disputes:** In the event of any dispute or disagreement arising between the vendor and any other department of AIIMS Jodhpur with regards to the interpretation of "Terms & Conditions" of this inquiry, the same shall be referred to the Executive Director, AIIMS Jodhpur whose decision will be final and binding.
16. AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.

 - **Copy of registration with Central/State Pollution Control Board.**
 - **Permission to the agency by the concern/Central/State Pollution Control Board for collection, disposal, storage of waste/scrap batteries as per the guidelines from Ministry of Environment & Forest.**
 - Copy of valid GST no.
 - Copy of valid PAN Card

3. Bidder submitting the bid has to make sure that rate of each individual item must be filled & no blank/unfilled column remain in the bid, else the bid shall be rejected.
