**General Terms and Conditions:**

1. The quotations received after **28<sup>th</sup> February, 2024 up to 3:00 PM**, or unsealed shall not be entertained under any circumstances whatsoever. ***In case of postal delay, this Institute will not be responsible.*** The offer Submitted by/through Fax/Email shall not be considered and no correspondence will be entertained in this matter.
2. Rates must be quoted in "**Indian Rupees**" and the quotation should give rates, showing taxes, and levies, if any. Quotations not confirming these requirements shall be rejected and no correspondence will be entertained whatsoever.
3. Quotations received after the deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay, the Institute will not be responsible.
4. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
5. The rates quoted must be valid for 180 days minimum from the date of opening of the quotation.
6. The technically qualified Bidder who submits **the highest rates shall be declared as a Successful bidder (H1) on composite basis** and communication to that effect shall be made subject to approval and as decided by the competent Authority.
7. Quotations qualified by such vague and indefinite expressions as "subject to prior confirmation", "subject to immediate acceptance" etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
8. The successful bidders must deposit the full quoted amount **within seven days** to the Institute from the date of issue of the Award of Letter.
9. The bidder who will quote the highest offer shall lift/take away the material auctioned within 07 days of issue of sale order but only after depositing the full amount offered to AIIMS Jodhpur.
10. The quotation document is non-transferable.
11. Decision of the Executive Director, AIIMS Jodhpur shall be final and binding on all issues/objections, and no inquiry will be entertained after quotation opening.
12. Any damage to the property of the AIIMS, if noticed, due to the fault of the successful bidder during lifting the items shall be recovered from the said firm and the decision of the Executive Director, AIIMS Jodhpur shall be binding the bidder.
13. Bidder submitting bids would be considered to have accepted all the term & conditions. No inquiry verbal or written shall be entertained in acceptance or rejections of the bid.
