All India Institute of Medical Sciences (AIIMS), Jodhpur, Rajasthan, an apex healthcare institute established by an Act of Parliament of India under aegis of Ministry of Health & Family Welfare, Government of India, invites Online bids in **two bid system** for **Supply of Wi-Fi access points and related accessories for the internet facilities in Hostel at AIIMS- Jodhpur.**

Instructions: -

1. Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>
2. The complete bidding process is online. Bidders should be possession of valid digital Signature Certificate (DSC) of class II or III for online submission of bids. Prior to bidding DSC need to be registered on the website mentioned above. For any assistance for e-bidding process, if required, bidder may contact to the helpdesk at 0291-2740741.
3. Bidder/Service Provider are advised to follow the instructions provided in the 'Instructions to the service providers/Bidders for the e-submission of the bids online through the Central Public Procurement Portal for e-Procurement at <https://eprocure.gov.in/eprocure/app>'.
Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

4. Criteria of eligibility:

Contractor who fulfill following requirement shall be eligible to apply. Joint ventures are not accepted:

- a. Contractor should have valid registration with Govt. / Semi Govt. organization like railways, PWD, CPWD/BRO/MES etc. or any PSU under state / central government in appropriate class/or having experience in carrying out the similar works.
- b. Should have satisfactorily completed the similar works as mentioned below during the last seven years ending 31st July, 2022.

Note: Completion certificate to be attached.

- i. Three (03) similar works each of value **not less than 40% (i.e for Rs.3,92,400/-)** of the estimated cost put to tender.
Or
- ii. Two (02) similar works each of value **not less than 60% (i.e for Rs.5,88,600/-)** of the estimated cost put to tender.

- iii. One (01) similar work each of value **not less than 80% (i.e for Rs.7,84,800/-)** of the estimated cost put to tender. **(Details should be mentioned in Annexures-II).**

Definition of similar work:

The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to the last date of previous month in which bids are received.

5. Bidder must have average annual turnover of at least **100%** of the tender value for the 3 consecutive financial years.

6.Submission of Tender:

The tender shall be submitted online in two part, viz. Technical Bid and Financial Bid. All the pages of bid being submitted must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents before uploading.

The said Performance Guarantee shall be a guarantee to execute all the works referred to in the tender documents upon the terms and conditions contained or referred to those in excess of that limit at the rates to be determined in the tender form. Further, I/We agree that in case of forfeiture of Performance Guarantee as aforesaid, I/We shall be debarred for participation in the re-tendering process of the work. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for tendering in **AIIMS, Jodhpur** in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Performance Guarantee. General Conditions of Contract

1. **Rate:** Rates to be quoted as per Financial Bid considering costs of material, taxes and delivery at site / FOR etc. Only GST will be paid extra as applicable after submission of GST tax invoice for the material supplied. The payment will be made after receipt of all the warranty cards duly authorized by the OEM and must be submitted with the tax invoice.
2. The rates shall be quoted only in the schedule of quantities attached with the tender and nowhere else i.e. letter heads etc.
3. **Validity:** The quoted rates must be valid for a period for 180 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected. In case the tenderer withdraws, modifies or change his offer during the validity period, bid is liable to be rejected and the bidders shall not be allowed to quote for any other tender of AIIMS- Jodhpur and the same shall also be intimated to their respective parent department from where they are registered without assigning any reason thereof. The bidder should also be ready to extend the validity, if required, without changing any terms, conditions etc. of their original tender. In case the last date of sale / of receipt of tender / of opening the tender is declared as Holidays, the respective dates shall be treated as postponed to the next working day accordingly.
4. **Technical Evaluation:**
 - a) Detailed technical evaluation shall be carried out by Institute pursuant to conditions in the tender document to determine the substantial responsiveness of each tender. For this clause, the substantially responsive bid is one that conforms to all the eligibility and terms and condition of the tender without any deviation.
 - b) The Institute's determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. The Institute shall evaluate the technical bids also to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are in order. The Director, AIIMS, Jodhpur shall have right to accept or reject any or all tenders without assigning any reasons thereof.
5. **Financial Evaluation:**

The financial bid shall be opened online of only those bidders who have been found to be technically eligible.
6. Right to issue and to accept or reject any or all tenders without assigning any reason thereof is reserved by the Competent Authority.
7. **Award of Contract:** The Institute shall consider placement of orders for jobs on those bidders whose offers have been found technical and financially acceptable. The Institute reserves the right to counter offer price(s) against price(s) quoted by any bidder.
8. **Performance guarantee:**
 - a. As a contract security for faithful performance of the contract in accordance with all the terms and conditions specified in the tender, the successful tenderer / contractor shall furnish a Performance bank guarantee @ 3% of order value in the form of Fixed Deposit Receipt or Bank Guarantee (as per attached format) from any Nationalized Bank duly pledged in the name of the "All India Institute of Medical Sciences, Jodhpur" after receipt of supply order.

- b. AIIMS-Jodhpur shall have the right to encash the PBG for non-compliance of any or all the terms and conditions of the tender / contract and to recover any Liquid Damages and penalties under the contract as enumerated in the tender / contract.
- c. **Refund of PG-** The Performance guarantee shall not be refunded till the contractor produces a clearance / completion certificate from the Engineer-In-Charge.

9. Security deposit:

- a. The person/persons whose tender(s) may be accepted (hereinafter called the contractor) shall permit Government at the time of making any payment to him for work done under the contract to deduct a sum @ **5% of the gross amount** of each bill till the sum deducted will amount to security deposit of @ **5% of the contract value of the work**. All compensations or the other sums of money payable by the contractor under the terms of this contract may be deducted from, or paid by the sale of a sufficient part of his security deposit or from the interest arising therefrom, or from any sums which may be due to or may become due to the contractor by Government on any account whatsoever and in the event of his Security Deposit being reduced by reason of any such deductions or sale as aforesaid, the contractor shall within 10 days make good in the same mentioned endorsed in favor of the Engineer-in-Charge, any sum or sums which may have been deducted from, or raised by sale of his security deposit or any part thereof.
 - b. **Refund of Security Deposit:** The security deposit shall not be refunded till the completion of warranty period and the contractor produces a clearance / completion certificate from the Engineer-In-Charge.
- 10. Authority of person signing document:** A person signing the tender form or any documents forming part of the contract on behalf of another shall be deemed to warranty, that he has authority to bind such other and if, on enquiry, it appears that the person so, signing had no authority to do so, the Director, AIIMS, Jodhpur may without prejudice to other Civil and criminal remedies cancel contract and held the signatory liable for all cost and damages.
- 11. Right of acceptance:** The institute reserve the right to accepting the whole or any part or portion of the bid; and the bidder shall provide the same at the rates quoted. The institute reserve the right to reject any or all tenders /quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained
- 12. Inspection:**
- (a) AIIMS, Jodhpur shall have the right to inspect and/or to test the goods to confirm their conformity to the NIT Specifications at no extra cost to the Purchaser.
 - (b) AIIMS, Jodhpur right to inspect, test and, where necessary, reject the Goods after the goods arrival at the final destination shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by AIIMS, Jodhpur prior to the goods shipment.
 - (c) The Director, AIIMS, Jodhpur shall be the final authority to reject full or any part of the work which is not confirming to the specification and other terms and conditions.
- 13. Subletting of Work:** The firm shall not assign or sublet the work/job or any part of it to any other person/party or will first obtain permission in writing from the Competent Authority of AIIMS, Jodhpur, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one bidder.

- 14. Breach of Terms and Conditions:** In case of breach of any terms and conditions as mentioned in tender, the Competent Authority, AIIMS-Jodhpur will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by AIIMS, Jodhpur in that event the PG shall also stands forfeited.
- 15.** After the evaluation of the bid(s) AIIMS, Jodhpur will award the contract to the lowest evaluated responsive bidder on composite basis. Conditional bid will be treated as unresponsive and will be rejected/liable to be summarily rejected.
- 16. Applicable Law:**
- The contract shall be governed by laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/ processing.
 - The Arbitration shall be held in accordance with the provision of the Arbitration and conciliations Act, 1996 and the venue of arbitration shall be at Jodhpur. The decision of the Arbitrator shall be final and binding on both the parties. Any disputes are subject to exclusive jurisdiction of competent court and forum in Jodhpur, Rajasthan, India only.
 - **Force Majeure:** Any delay due to Force Majeure will not be attributable to the service provider.
- 17.** The quantities are approximate and are liable to change up to any extent on either side. The Engineer-in-Charge reserves right to order deviation from the quantities mentioned in the tender. The contractor shall supply the additional quantity on the rates quoted in the tender documents irrespective of deviation limit mentioned elsewhere in the agreement. The contractor shall have no claim to any payment or compensation whatsoever on account of any profit or advantage which he might have derived from the execution of supply in full as mentioned in tender but which did not derive any consequence of the full supply of material mentioned in tender not having been ordered.
- 18. Breach of Terms and Conditions:** Non-compliance of any terms and conditions enumerated in the contract shall be treated as breach of contract. Or in Case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by AIIMS, Jodhpur in that event the PG shall also stands forfeited.
- 19.** Contractor shall be fully responsible for any damages caused to govt. property or allottee's property by his or his labour in carrying out the work and shall be rectified by the contractor at his own cost.
- 20.** Rejected materials shall have to be removed by the contractor at his own cost within a week of the instructions of doing so. Also go down rent as decided by Engineer-in-Charge shall be charged by the department.
- 21. Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty @ **0.5 % per week of the total order value** shall be levied subject to maximum of **10%** of the total order value.
- 22.** In case of any discrimination, the decision of the Director, AIIMS- Jodhpur shall be final and binding on the bidder / contractor.
- 23.** In absence of any condition / clause, the general conditions of contract of CVC / CPWD / GFR shall be taken in account.
