General Terms & Conditions:

- 1. The quotations received after 04.06.2025 up to 3:00 PM or unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay, this Institute will not be responsible. The offer submitted by/through Fax/Email shall not be considered, and no correspondence will be entertained in this matter.
- 2. Quotations must be in the enclosed prescribed format duly signed by the Proprietor/Partner/Director or their 2 Authorized Representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur. Quotation must be in a sealed envelope super scribed with inquiry number.
- 3. Rates must be quoted in "Indian Rupees" and bidder should give rates, showing taxes, levies, if any, in the prescribed format. Quotation not conforming to these requirements shall be rejected and no correspondence will be entertained whatsoever.
- 4. Rates must include Freight (Transportation) charges.
- 5. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- 6. The rates quoted must be valid for 90 days minimum from the date of opening of the quotation.
- 7. L1 will be decided on composite basis. Becoming L1 will not be the criteria for awarding of work unless the rates are reasonable & justified.
- 8. RTGS/NEFT details need to be furnished by the bidder with the quotation on the Annexure A.
- 9. Quotations qualified by such vague and indefinite expressions such as "subject to prior confirmation", "subject to immediate acceptance" etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
- 10. The time allowed to deliver scaffolding (as per details mentioned in Annexure A) is 15 days from the date of issue of award letter.
- 11. The contractor shall be fully responsible for any damages caused to govt. property or allottee's property by his or his labour in carrying out the work and shall be rectified by the contractor at his own cost.
- 12. Disputes: In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Jodhpur with regards to the interpretation of "Terms & Conditions" of this inquiry, the same shall be referred to the Executive Director, AIIMS Jodhpur whose decision will be final and binding. Any disputes are subject to exclusive jurisdiction of competent court and forum in Jodhpur, Rajasthan, India only.
- 13. The Arbitration shall be held in accordance with the provision of the Arbitration and conciliations Act, 1996 and the venue of arbitration shall be at Jodhpur. The decision of the Arbitrator shall be final and binding on both the parties.
- 14. AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the AIIMS, Jodhpur will be final in this regard.
- 15. The contract shall be governed by laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/processing.

- 16. Force Majeure: Any delay due to Force Majeure will not be attributable to the service provider.
- 17. Liquidated Damage: If the supplier fails to execute the work within 15 days, then a penalty @ 0.5 % per week of total order value shall be levied subject to maximum of 10% of the total order value.
- 18. The near relatives of employees of AIIMS, Jodhpur are prohibited from participation in this tender. The near relative for this purpose are defined as:
 - i. Members of a Hindu Undivided Family.
 - ii. Their spouses
 - iii. The one related to the other in the manner as father, son(s), Son's wife (daughter-in-law), daughter(s) and daughter's husband (sons-in-law) brother (s) and brother's wife, sister(s) and sister's husband, brother(s)-in-law

- 2. The contractor has to serve **one year of warranty** period for scaffolding supplied.

3. Security deposit:

Security Deposit @2.5% will be deducted from the bills of the Contractor.

Refund of Security deposit: The amount deducted from the contractor's bill/s as security deposit shall be refunded after the completion of one year (i.e., after the completion of the warranty period).
