#### 1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.
- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:

- K) **Delivery Period** within 30 days from Purchase order.

#### Specification of Mannequin for Cervical Dilatation & Labour Progress

- 1. Model should provide realistic simulation of cervical examination prior to birth.
- 2. Should have and tactile sensations which provide a positive transition to patient procedures.
- 3. Should contain a set of 6 interchangeable cervices ranging from 0 or 1cm to 10cm dilatation and progressive effacement.
- 4. These set of cervices should also have amniotic membranes and fetal stations from -3 to +3 station.
- 5. The external appearance of all blocks should be identical but with the variations being in the internal structure.
- 6. The internal texture, tissue density and anatomical size should represent to provide realistic condition possible.
- 7. Each variant is clearly identified on the back side to indicate which conditions exists internally.
- 8. Should include six simulation blocks, acrylic stand, instruction card and a hard carry case.
