#### 1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.
- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
  - Firm shall be registered with the Government of Rajasthan / Central Government.
  - The firm shall have valid GST No.
  - The firm should not be black listed by any Govt. Agency/Dept.
- J) Quotations qualified by such vague and indefinite expressions such as "subject to prior

confirmation", "subject to immediate acceptance" etc. will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.

- K) **Delivery Period** within 30 days from Purchase order.

#### **Technical Specification for Pulse Oximeter:-**

- 1. Should have heart rate, saturation (Sp02), ECG, RR, temperature, NIBP and IBP facility
- 2. Monitor should measure neonatal and paediatric patient's parameters.
- **3.** Display should be maximum 6" TFT colour gorilla screen with auto rotation feature with respect to gravity.
- **4.** Weight should not be more than 3 kgs. with battery.
- **5.** Should have provision to work on both AC mains and battery (Li-Ion battery).
- **6.** It should be a high resolution touch display with configurable screen layouts.
- 7. Rechargeable Li-Ion battery should be available with back up of minimum 5 hrs.
- **8.** Monitor should have minimum 48 hrs of trend memory
- **9.** Audio and visual alarms should be available
- **10.** Monitor should have capability to be used as module/ server for high-end ICU monitors /modular monitors with facility to transfer patient data seamlessly to the main ICU monitor when patient is back on bedside after in-hospital/ out of hospital transportation.
