#### 1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.
- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
  - Firm shall be registered with the Government of Rajasthan / Central Government.
  - The firm shall have valid GST/Other taxes and IT PAN.
  - The firm should not be black listed by any Govt. Agency/Dept.

### Specification of Portable Vein Locator with skin vein mapping:-

- 1. Device should be portable easy to operate and locate the vein for cannulation in patients with minimum discomfort or trauma to patients.
- 2. Should have dual visualization of vein on the skin as well as on the Devices screen during skin mapping.
- 3. Should be lightweight and portable.
- 4. Should have built in Rechargeable Battery.
- 5. Should have LED type projector of Reflective type.
- 6. Should help in accurate puncturing in single attempt and hence precious time during drug administration.
- 7. Should be able to use on patient with difficult skins-Burns, wrinkled and difficult tones whether he is Adult, Paediatrics or Neonate.
- 8. Should have accurate visualization to minimize the number of attempts & reduce the chances of infection.
- 9. Should weight up to 250 grams.
- 10. Should have dimension of 190mm X 60mm X 12mm (±5mm).
- 11. Should have depth of visualization up to 10mm of skin.
- 12. Should have light type near to Infrared for better visualization.
- 13. Battery should last at least 2-3 hours during active use.
- 14. Charger should be of 5V USB Type.
- 15. Should be able to operate between 4°C to 48°C.
- 16. Should have option of Flexible Mounting Options with Fast/ Table Clamp of Roller stand.
