2. You will have to report to the undersigned by **17th September 2012 at 9.00 A.M. at the Project Cell Office, Residential Complex, AIIMS, Jodhpur.**
3. You will have to submit a medical certificate from Civil Surgeon/ Chief Medical Officer of your district. You may please note that if you are found medically unfit, to be admitted to this course then you will not be admitted and the decision of the Civil Surgeon/ Chief Medical Officer shall be the final. (Letter enclosed)
4. You are advised to come with arrangement for approximately Rs. 20,000/- to allow you submit admission fees and bear the settling cost,. Dues. In case, the said amount is not paid on the stipulated date, your name will be deleted from the list of candidates selected for admission to the above course and the seat will be offered to the next candidate on the waiting list.
5. Please note that Institute shall not reimburse any expenditure incurred by you on account of travel and maintenance in connection with your joining the Institute.
6. You are required to furnish separate affidavits by you and parents/guardian on a non-judicial stamp paper of Rs.10/-. Copies of the specimen are enclosed as per Annexure-I and II.
7. At the time of joining the course, you are required to furnish the undertakings as per enclosed formats.

8. You are required to bring the following certificates & documents in original to be verified by the undersigned by 17th September 2012.
- (i) Certificate of having passed the 10+2 or equivalent examinations, showing the subjects offered by you in the examination.
 - (ii) Certificate from the Board from which you passed the High School/Higher Secondary Examination, Showing your date of birth.
 - (iii) Certificate/ Mark sheet from the Board from which you passed the 10+2 or equivalent examination, showing that you have secured 60% marks or above in aggregate in the subjects of English, Physics, Chemistry (Organic & Inorganic) and Biology (Botany & Zoology). In case of Scheduled case/Scheduled tribe candidates, you have secured 50% marks or above in aggregate in the subjects of English, Physics, Chemistry (Organic & Inorganic) and Biology (Botany & Zoology).
 - (iv) Migration certificate from the university/Board last attended by you.
 - (V) Certificate from the prescribed authority on the prescribed form as appended in the prospectus showing that you belong to scheduled caste/Tribe/Orthopedic Physically Handicapped Category (Applicable only if you have claimed in your application that you belong to a scheduled caste/Tribe/Orthopedic Physically Handicapped Category).
 - (VI) Current Passport size photograph (front pose) 6 Copies.

Failure to produce the above mentioned certificates and documents in original by you will lead to cancellation of your candidature and the seat will be offered to the next candidate on the waiting list.
