### **Instructions for the Tenderer/ Contractor/ Bidders:-**

- Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>.**
- The complete bidding process in online. Bidders should be possession of valid digital Signature Certificate (DSC) of class II or III for online submission of bids. Prior to bidding DSC need to be registered on the website mentioned above. For free of cost training of e-bidding process, if required, and for any other assistance bidder may contact to the helpdesk at 0291-2740741.
- Tenderer/Contractor/Bidders are advised to follow the instructions provided in the ‘Instructions to the Contractors/Tenderer/Bidders for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app>’.**
- Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- EMD Payment:**  
The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of **Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand Only)** by way of demand drafts or Bank Guarantee only. The demand drafts shall be drawn in favour of **“All India Institute of Medical Sciences, Gorakhpur”**. **The demand drafts or Bank Guarantee for earnest money deposit must delivered to the AIIMS, Gorakhpur on or before bid closing date/time (submitted only in Dispatch/Received section).** The EMD of the successful bidder shall be returned after the successful submission of Bank Guarantee/ Security Deposit and for unsuccessful bidder(s) it would be returned after award of the contract. Bid(s) received without demand drafts of EMD will be rejected.
  - Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fail to observe and comply with stipulation made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited.

- The Firm who are registered with National Small Industries Corporation (NSIC) / OR Small Scale Industries (SSI) are exempted to submit the EMD (Copy of registration must be provide along with technical bid)
  - The EMD, in case of unsuccessful Bidders shall be retained by AIIMS, Gorakhpur till the finalization of the tender. No interest will be payable by AIIMS, Gorakhpur on the EMD.
6. **The Hard Copy of original, documents instruments in respect of cost of earnest money deposit must be delivered to the AIIMS, Gorakhpur on or before last date/time of Bid Submission as mentioned above (submitted only in Dispatch/Received section) at AIIMS, Gorakhpur. The bid without EMD will be summarily rejected.**
7. **Sample: The Bidder must submit the sample of product (as mentioned in annexure III) for technical evaluation at AIIMS Gorakhpur on or before last date/time of Bid Submission (submitted only in Dispatch/Received section). Failure to submit the sample at the time of submission of their bids/offer will be summarily rejected.**
8. Bidders are requested to quote their prices on a firm & fixed basis for the entire period of the Contract. Bids of the firms received with prices quoted on variable basis shall be rejected without assigning any reasons and no communication in this regard shall be made.
9. **Submission of Tender:**  
The tender shall be submitted online in two part, viz., technical bid and financial bid (in attached BOQ in CPP Portal). All the pages of bid being submitted must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents before uploading.

**The offers submitted by Telegram/Fax/email/Hard Copy shall not be considered. No correspondence will be entertained in this matter.**

**I. Technical Bid**

The following documents are to be furnished by the bidder in CPPP Portal.

- a. Copy of Demand draft of Rs. 1,50,000/- (Refundable) against EMD or NSIC/MSME Certificate.
- b. Duly filled format of Technical Bid as per Annexure – II.
- c. **Financial Status:** - Having at least following work of similar magnitude as per below mentioned criteria during the last three years:
  - a. One similar work of not less than Rs.60,00,000/- in one year in last three year.  
OR
  - b. Two similar work of not less than Rs.45,00,000/- in one year in last three year.  
OR
  - c. Three similar work of not less than Rs.30,00,000/- in one year in last three year.

- d. Bidder must have an average annual turnover of Rs. 75 lakh during the last 3 financial years (Documentary proof like financial statement /Balance sheet from Chartered Accountant/ equivalent statutory authority to be submitted).
- e. Copy of Income Tax Return Acknowledgement for last Three years.
- f. Copy of PAN Registration.
- g. Copy of GSTIN Registration Certificate.
- h. **Manufacturer Authorization Certificate. (Certificate must be uploaded by Bidder).**
- i. Details of clients where similar services are presently provided by the tenderer separately for govt. and private clients.
- j. Brochure, original technical catalogue with detailed specification and picture of the product offered, if relevant
- k. Signed Annexures of Tender document.
- l. All other document mentioned in tender document.

II. **Financial Bid – Bidder must submitted the financial bid in attached BOQ in CPP Portal.**

## General Term & Conditions

1. **"PRE –BID Meeting" with the intending bidders shall be held on 23<sup>rd</sup> August, 2019 from 11:00 A.M. onwards at AIIMS, Gorakhpur.** All the prospective bidders are requested to send comments/ representations on or before pre-bid meeting. Intending bidder will be allowed to seek clarification on specification, Conditions of Contract, etc. in writing to AIIMS, Gorakhpur, at the time of pre-bid meeting or within 2 hours after the pre-bid meeting, after stipulated time no clarification will be entertained.
2. **Validity:** The quoted rates must be valid for a period for 180 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.

In case the tenderer withdraws, modifies or change his offer during the validity period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof. The tenderer should also be ready to extend the validity, if required, without changing any terms, conditions etc. of their original tender.

3. **Technical Evaluation:**

(a) Detailed technical evaluation shall be carried out by Institute pursuant to conditions in the tender document to determine the substantial responsiveness of each tender. For this clause, the substantially responsive bid is one that conforms to all the eligibility and terms and condition of the tender without any deviation. The Institute's determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. The Institute shall evaluate the technical bids also to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are in order.

(b) AIIMS Gorakhpur shall have right to accept or reject any or all tenders without assigning any reasons thereof.

4. **Financial Evaluation:**

(a) The financial bid shall be opened of only those bidders who have been found to be technically eligible.

(b) If, in the price structure quoted for the required goods, there is discrepancy between the unit price and total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly.

(c) If there is a discrepancy between words and figures, the amount in words shall prevail.

(d) After due evaluation of the bid(s) AIIMS, Gorakhpur will award the contract to the lowest evaluated responsive tenderer. Conditional bid will be treated as unresponsive and will be rejected.

(e) Bidder must quote the financial bid as specified in BOQ.

5. **Contract Period:** The rate contract for Supply & Installation of Blinds initially for a period of (1) one year and can be continued / renewed for further (1) year subject to satisfaction of the All India Institute of Medical Sciences (AIIMS), Gorakhpur and on mutual consent of both the parties subject to the condition/ rules framed by the Government of India from time to time.
6. **Installation:** - All the work shall be completed within 30 days from the date of issue of work order by the Institute. All the aspects of safe installation shall be the exclusive responsibility of the supplier. If the supplier fails to complete the work on or before the stipulated date, then a penalty at the rate of 0.5% per week of the order value shall be levied subject to maximum of 10 % of the order value.
7. **Warranty / Guarantee:** - Bidder must provide one (01) year comprehensive on-site warranty and it will be started from the date of the satisfactory installation / commissioning of goods, against the defect of any manufacturing, workmanship and poor quality of the components. No offer of the vendor will be accepted without warranty/ guarantee of their supplied/ installed goods.
8. **Signing the Contract:** - The successful bidder shall be required to execute the Contract Agreement accepting all terms and conditions stipulated herein on a non-judicial stamp paper of Rs. 500/- (Rs. Five Hundred only) along with performance security within fifteen days of the issue of the Letter of notification of award. In the event of failure on the part of the successful bidder to sign the Contract within the period stipulated above, the EMD shall be forfeited and the acceptance of BID shall be considered as cancelled.
9. **Performance Security:** - The Successful Contractor will be required to furnish an amount @ 10% of Total Annual Contract Value (inclusive of GST) as a performance security in the form of Fixed Deposit Receipt or Bank Guarantee from any Nationalized Bank duly pledged in the name of the "**All India Institute of Medical Sciences, Gorakhpur**" payable at Gorakhpur within 30 days from the award of contract. Security Deposit shall be kept valid for a period of 60 days beyond completion of all the contractual obligations.

The security deposit can be forfeited by order of this Institute in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non – observance of any condition of the contract.

In case, the successful bidder shows inability at any stage, after the contract is finalized and awarded for whatsoever reason(s), to honor the contract, the EMD/Performance Security deposited would be forfeited.

Performance Security will be discharged after 60 days from the completion of contractor's performance obligations under the contract.

10. **Quality of goods:** The firm will be entirely responsible for quality of supplied goods/ materials. The supplier should replace the rejected/ damaged stores within 07 days, failing which penalty will be imposed 0.5% per week of the total ordered value shall be levied subject to maximum of 10 % of the total ordered value by the Institute.

**11. Payment Term:** The Bill in triplicate may be send to this office for settlement after satisfactorily delivery against each order. The bill should have full particulars of the items. Payment shall be made to successful bidder only in Indian rupees.

No Payment shall be made in advance nor shall the loan from any financial institutions be recommended on the basis of the order of award of work. The Contractor shall submit the bill only after satisfactorily delivery of the material to the satisfaction of the AIIMS, Gorakhpur.

The case of issuing sanction and passing of bill for payment will be initiated on receipt of a pre-receipted bill invoice from the Contractor. No payment will be made for goods rejected.

**12. Inspection: -**

- a) AIIMS, Gorakhpur shall have the right to inspect and/or to test the goods to confirm their conformity to the NIT Specifications at no extra cost to the Purchaser.
- b) AIIMS, Gorakhpur right to inspect, test and, where necessary, reject the Goods after the goods arrival at the final destination shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by AIIMS, Gorakhpur prior to the goods shipment.
- c) The Director, AIIMS Gorakhpur shall be the final authority to reject full or any part of the supply which is not confirming to the specification and other terms and conditions.
- d) No payment shall be made for rejected Stores. Rejected items must be removed by the Bidders within two weeks of the date of rejection at their own cost and replaced immediately. In case these are not removed, these will be auctioned at the risk and responsibility of the suppliers without any further notice.

**10. Documents: -**

- a) All pages of the Tender should be numbered and indexed.
- b) The bidder shall provide in its tender the required as well as the relevant documents like technical data, literature, drawings etc. to establish that the goods and services offered in the tender fully confirm to the goods and services specified by the purchaser in the tender documents. For this purpose the bidder shall also provide a clause-by-clause commentary on the technical specifications and other technical details incorporated by the purchaser in the tender documents to establish technical responsiveness of the goods and services offered in its tender duly indicating relevant page numbers in the product literature.

**17. Arbitration:** If any difference arises concerning this agreement, its interpretation on payment to the made there-under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an Arbitral Tribunal containing Sole Arbitrator to be appointed by the Secretary, Department of Legal Affairs. Such requests shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation

Act, 1990 and the rule framed there under and in force shall be applicable to such proceedings.

- 18. Subletting of Work:** The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of AIIMS, Gorakhpur, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one tenderer.
- 19. Breach of Terms and Conditions:** In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the work order/ job without assigning any reason thereof and nothing will be payable by AIIMS, Gorakhpur in that event the security deposit shall also stands forfeited.
- 20. Insolvency etc:** In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other order under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified AIIMS, Gorakhpur shall have the power to terminate the contract without any prior notice.
- 21. Force Majeure:** If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by party to other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries have been so resumed or not shall be final and conclusive.  
  
Further, that if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, either party may, at least option to terminate the contract.
- 22. Legal Jurisdiction:** - The agreement shall be deemed to have been concluded in Gorakhpur, Uttar Pradesh and all obligations hereunder shall be deemed to be located at Gorakhpur/Lucknow, Uttar Pradesh and Court within Gorakhpur/Lucknow, Uttar Pradesh will have Jurisdiction to the exclusion of other courts.
- 23. Right to call upon information regarding status of work:** The AIIMS, Gorakhpur will have the right to call upon information regarding status of work / job at any point of time.
- 24.** Bidder shall upload a copy of the tender document and addenda thereto, if any, with each page of this document should be signed and stamped to confirm the acceptance of the entire terms & conditions as mentioned in the tender enquiry document.

25. Bidders are requested to quote their prices on a firm & fixed basis for the entire period of the Contract. Bids of the firms received with prices quoted on variable basis shall be rejected without assigning any reasons and no communication in this regard shall be made.
26. The quantity of item given in the tender is tentative, which may be increased or decreased as per the institute's requirement.
27. No escalation in rates on any account will be permitted during the contract period. Also, no subsidy will be given over the quoted rates.
28. Signed & stamped compliance sheet of the technical specification of the goods with technical printed literature must be enclosed with the bid.
29. After due evaluation of the bid(s) Institute will award the contract to the lowest evaluated responsive tenderer
30. Conditional bid will be treated as unresponsive and it may be rejected.
31. The Income Tax/ Any other Taxes as applicable shall be deducted from the bill unless exempted by the Income-tax department.
32. The bidder, once applied, will not be allowed to withdraw at any stage. If the bidder wants to withdraw, the entire amount of EMD will be forfeited.
33. The Tenderers should furnish a copy of PAN Number and GSTIN Registration Number. Tenders not complying with this condition will be rejected.
34. Please states whether business dealings with your firm presently stand banned, Blacklisted by any Government organization and, if so, furnish relevant details (Refer annexure - II).
35. The items will have to be supplied at Institute site. No transportation/ cartage charges will be provided for the same.
36. AIIMS, Gorakhpur shall be the sole authority to cancel or amend the order, as per requirement, and also to place order for supply of item beyond office hours/holidays/place of supply for which, no additional payment shall be made.
37. The successful Tenderer shall also provide the name and mobile no of key person, who can be contacted at any time, even beyond the office hours on holidays. The person should be capable of making arrangement for supply of the desired items even on short notice to AIIMS, Gorakhpur.
38. The firm has not been blacklisted in the past by any government/ Private institution and there is no Vigilance/CBI case pending against the firm supplier.
39. The Institute reserves the right to accept in part or in full or reject any or more tender(s) without assigning any reasons or cancel the tendering process and reject all tender(s) at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder(s).
40. **Applicable Law:**

- The contract shall be governed by the laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such Commercial dealings / processing.
- Any disputes are subject to exclusive jurisdiction of Competent Court and Forum in Gorakhpur/Lucknow, Uttar Pradesh, India only.
- The Arbitration shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the venue of arbitration shall be at Gorakhpur. The decision of the Arbitrator shall be final and binding on both the parties.
- Force Majeure: Any delay due to Force Majeure will not be attributable to the supplier.

Fire classification of fabric NFPA 701-2004 (small scale), BS 5768-2008 Part 2 Type B Performance Fabric should be Bacterial & Fungus free, Green guard & Lead free, normal thickness of fabric shall be 0.50mm and minimum weight 255gsm, hanging excellent hanging properties and very high tear strength. The fabric shall be suspended from the top channel made of extruded alloy of 1.25mm nominal thickness and 38mm nominal diameter. The top channel shall be fixed with powder coated mild steel bracket with clutch assembly on either end of blind, fixed to jambs of the window opening with 50 mm stainless steel screw with nylon roll plug and to the aluminium window with 25mm self thread screw. The operating mechanism shall be operated with plastic ball chain having 4.50 mm balls made of ABS plastic linked with 1.50 mm polyester cord. The mechanism shall allow the blind to stop in desired position with the clutch mechanism. The bottom channel shall be made of rectangle shape with extruded aluminium tube with powder coating. The fabric shall be enclosed in suitably created pocket along the tubes, which shall be closed from side with end caps of same colour to the bottom roller. All exposed components of roller blind shall be of milky white colour.
