1	5 Max Reperfusion Catheter	Required for thrombus aspiration from ICA and proximal MCA in cases of acute stroke
2	3 Max Reperfusion Catheter	Required for thrombus aspiration from distal MCA and in cases of acute stroke
3	Aspiration Tubing and Cannister	Reusable item required for connecting the catheter to the aspiration pump
4	Max aspiration pump	Required for suction of the thrombus


