**Specs for Pocket Ultrasound**

- It should be pocket size visualization tool providing black and white anatomic and color-coded blood flow images in real-time.
  - The weight should be less than 0.5kg.
  - The images should be generated based on ultrasound technology.
  - It should be approved for cardiac, abdominal, pediatric and selected peripheral vascular applications, for evaluating urinary bladder, obstetrics and gynecology as well as for thoracic and pleural fluid and motion detection.
  - It should be handheld and helps to enable personalized use at the point of care.
  - It should offer an immediate look beyond patient vital signs with the potential to identify critical issues like abdominal aortic aneurysm and fluid around the heart, and to monitor cardiac activity.
  - It should can easily be slid into docking station utilizing immediately the two connections provided (universal power supply with 100-240 V~ 50/60 Hz and global plugs (NEMA, BS, AS/NZS, Europlug), USB 2.0) allowing recharging of battery and USB connection to PC beside convenient placement with dedicated probe holder.
  - Memory card: 4 GB Micro-SD memory card
  - AC adapter: Secondary or replacement universal power supply with 100-240 V~ 50/60 Hz and global plugs (NEMA, BS, AS/NZS, Europlug) which can be connected with docking station as well as with separate battery charger


