4. The posts carry usual allowance as admissible to Central Government Employees of similar status stationed at Jodhpur (Rajasthan).

Application form only in the prescribed format for respective post of the eligible candidates whose services can be spared immediately on selection, together with the certificate from Forwarding Authority (in prescribed proforma) along with the following documents needs to be submitted Through Proper Channel only:
