Sealed Quotations are hereby invited from the vendors/supplier/contractor on behalf of the Executive Director, AIIMS, Jodhpur, for the "Supply, Installation, Testing, and Commissioning of CCTV Surveillance Security camera systems at various locations of AIIMS, Jodhpur. The filled quotations, along with all required documents, must be dropped in the "Quotation Box" located in the Administration Block of AIIMS, Jodhpur, On or before **17th May, 2024 up to 3:00 PM.** The sealed and super scribed Envelope containing the filled quotation (no Carbon Copy) would be as under: -

General Terms and Conditions:

1. The quotations received after 17th May, 2024 or Carbon Copy/unsealed and Signed shall not be allowed under any circumstances. **In case of postal delay, this Institute will not be responsible. The offer Submitted by/through e-mail shall not be considered and no correspondence will be entertained in this matter.**
2. Quotations must be in the enclosed prescribed format duly sealed and signed by the Proprietor/Partner/Director or their Authorized Representative; in case of signing of quotation by the authorized representative, a letter of authorization must be attached with the quotation.
3. Rates must be quoted in **"Indian Rupees," and also showing taxes and levies**, if any. Quotations not conforming to these requirements shall be rejected, and no correspondence will be entertained whatsoever.
4. Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
5. No overwriting or cutting is permitted in the Rates, Quantity, and total amount, if found, the quotation shall be summarily rejected.
6. The time allowed to complete the work of SITC as per details mentioned in Annexure-A is 10 Days from the date of issue of the work order.
7. The Bidder/Contractor is fully responsible for any damage caused to the govt. property or allottee's property during carrying out the work, the same shall be rectified by the contractor at his own cost.
8. RTGS/NEFT details need to be furnished by the supplier with a quotation in Annexure A.
9. The lowest one, or L1, will be decided on a composite basis.
10. The rates quoted must be valid for 90 days minimum from the date of opening of the quotation.
11. Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.

12. Quotations qualified by such vague and indefinite expressions as "subject to prior confirmation," "subject to immediate acceptance," etc., will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
13. The quotation document is non-transferable.
14. *The Interested Bidder must visit the site before quoting the price.*
15. The firm/agency may satisfy the following conditions and attach a self-attested copy of the same with the quotation: -
 - The firm shall have valid GST/Other taxes and IT PAN.
 - The firm should not be blacklisted by any Govt. Agency/Dept.
16. The bidder submitting bids would be considered to have accepted all the terms & conditions. No inquiry, verbal or written, shall be entertained in acceptance or rejection of the bid.
17. **Disputes:** In the event of any dispute or disagreement arising between the bidder and any other department of AIIMS Jodhpur with regard to the interpretation of the "Terms & Conditions" of this inquiry, the same shall be referred to the Executive Director, AIIMS Jodhpur whose decision will be final and binding.
18. The decision of the Executive Director, AIIMS Jodhpur, shall be final on all issues/objections, and no inquiry will be entertained once the quotation opens.
19. The Executive Director, AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of the inviting quotation process without assigning any reason. The decision of the Executive Director, AIIMS, Jodhpur, will be final.

Special Terms and Conditions:

1. The Bidder must supply, install, and make the entire system and handed over to the engineer in charge.
2. The Successful Bidder should inform and shown the material to the Engineer-In-Charge before executing the work.
3. The Bidder must execute the work during Office hours only.
4. The Bidder must quote the product as per the make and specification provided in Annexure-A.
5. The Bidder Must Install the CCTV Cameras and allied accessories as per the Engineer-In-Charge's directions.
6. The Bidder/Contractor is fully responsible for the safety of all labor/employee/technicians deployed at the site.
7. The Bidder must submit the inventory list after the completion of the work to the Engineer-In-Charge.
8. The invoice against the works shall be submitted only after successful completion of the work; the sealed and signed warranty cards, clearly mentioning the details of warranty periods also be submitted along with the invoice to the Engineer in charge.
9. The Successful Bidder must arrange all types of tools and special T&P etc. at its own cost to carry out the work, nothing shall be paid extra in this regard.
10. There shall be no liability on the AIIMS Jodhpur to pay any compensation in case of a labor dispute or accident etc, at the site.
11. The Successful bidder is responsible for watch and ward of their materials. AIIMS Jodhpur shall not be responsible for damage/missing of any material.
12. Proper Laying of the CCTV Network Cables inside the false ceiling, Installation of Network Racks, PoE Switches inside all Network Racks, and allied accessories must be installed as per the direction of the Engineer-In-Charge.

13. Liquidated Damage: If the Bidder fails to Execute the works on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to a maximum of 10% of the total order value.

14. Payment Terms: Payment will be only after satisfactorily Completion of Works and after the inspection by the Engineer-In-Charge.
