1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. **The offer submitted through Fax/Email shall not be considered and no correspondence will be entertained in this matter.**
- B) Quotations must be enclosed in the prescribed format on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in “**Quotation Box**” located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian Rupees** and as per the format specified. Taxes extra, if any, must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
- Firm shall be registered with the Government of Rajasthan / Central Government.
 - The firm shall have valid GST/Other taxes and IT PAN.
 - **The firm should not be black listed by any Govt. Agency/Dept.**

- K) **Delivery Period** – within 30 days from Purchase order.
- L) **Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
- M) **Payment Terms:** Payment will be only after satisfactorily delivery / commissioning of material and after inspection by the AIIMS Jodhpur.

Technical Specifications of Vitalstim Plus Electrotherapy and sEMG Biofeedback System

1. The unit must be designed to treat patients with swallowing disorders (dysphagia) through muscle re-education.
2. Must have 4 independent electrotherapy channels with independent intensity setting
3. Must have 2 clinical waveform options: Vitalstim & VMS.
4. VMS waveform must have channel mode options of continuous, reciprocal & co-contract.
5. Output intensity must not cross 25mA.
6. Must have 'ramp' up feature providing gradual, automatic and smooth intensity increase during treatment.
7. Must have sEMG for bio-feedback with sensitivity of 0.1 microvolt RMS.
8. Must be able to use as standalone sEMG and sEMG triggered stimulation.
9. Must have a heart beat filter to eliminate heart beat signals that might affect the sEMG signal.
10. Must have electrode placement guidelines for treatment.
11. Must have anatomical library with dysphagia image of anatomy, pathology and therapeutic treatment options of neck and face to assist the therapists and patients.
12. Must have facility to save customized patient treatment protocols.
13. Must be able to transfer therapy information to computer.
14. The unit must be light weight, portable and battery operated.
15. Supply with 24 electrodes and 4 nos. of AA 1.5V battery.
16. Must have US FDA or CE certification.
