1. Terms & Conditions:

- A) The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer Submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.
- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located in Administration Block of AIIMS, Jodhpur.
- C) Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F) The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- H) RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- I) The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
 - Firm shall be registered with the Government of Rajasthan / Central Government.
 - The firm shall have valid GST No.

- The firm should not be black listed by any Govt. Agency/Dept.

It should be a hospital grade breast pump; capable of working 24X7 in a hospital and can be used by several mothers; one user at a time. 3. It should be easy to operate and provides safe, hassle-free, comfortable and painless pumping experience. 4. It should have a compact portable construction; easily movable. 5. The operation of pump should be automatic. 6. The vacuum needs to be variable and there should be a system by which the vacuum can be adjusted as per the comfort level. 7. The pumping speed needs to be variable. The number of suction cycles per minute needs to be regulated as per requirement. 8. The parts of the pump which comes in direct contact with breast milk should be made of food grade hygienic material which is safe for newborn baby and easy to clean and sterilise. 9. During expression milk will be stored in a bottle attached to the breast shield and there should be no chance of entering milk into the pumptubing as well as the pump. 10. During expression, the expressed breast milk should not be exposed to the environment. The system must be designed in such a manner so that it will protect the outside air from reaching the expressed milk. 11. During expression, milk will be stored in a bottle and there should be no chance of contamination from the outside environment. 12. The collection system should provide a barrier in between the pumptubing and the breast shield, which prevents outside air from reaching the expressed milk. 13. Power supply: It should be capable of functioning in power supply of 230V AC, 50Hz. 14. It should be a safety certified approved product (USFDA and CE). 15. Manufactures/ suppliers should have ISO certificate to Quality Standard. 16. Electrically safety conforms to the standards for electrical safety. 17. Accessories/fittings sets (like tubing, breast shield, connector, valve, membrane, membrane cap, reusable bottles etc.) must be reusable. 18. The equipment should be supplied with all ac	01 Nos.
