3. The Recruitment is provisional and subject to variation, if necessary. The Principal Investigator (PI) reserves the right to make any amendment, cancel and make changes to this advertisement as a whole or in part without assigning any reason or giving notice. The post is for the specified period and based on the project, which may be modified as per requirement at the discretion of the Principal Investigator.

4. The above post would be filled purely on a <u>temporary basis</u>, co-terminus with the project & the candidate will have NO right to claim for permanent Employment under AIIMS, Jodhpur or continuation of his/her services in any other project.
