All India Institute of Medical Sciences (AIIMS), Jodhpur, Rajasthan, an apex healthcare institute established by an Act of Parliament of India under the aegis of the Ministry of Health & Family Welfare, Government of India, invites **Percentage rate tender** in two bid system for Shifting of existing electrical and HSD services at AIIMS-Jodhpur.

1. Bids shall be submitted online only at the CPP portal:

<https://eprocure.gov.in/eprocure/app>.

2. The complete bidding process is online. Bidders should have a valid digital Signature Certificate (DSC) of class II or III for online submission of bids. Before bidding DSC needs to be registered on the website mentioned above. For any assistance for the e-bidding process, if required, a bidder may contact the helpdesk at 0291-2740741.

3. **Bidder/service provider is advised to follow the instructions provided in the ‘Instructions to the service providers/Bidders for the e-submission of the bids online through the Central Public Procurement Portal for e-Procurement at <https://eprocure.gov.in/eprocure/app>’. Bid documents may be scanned with 100 dpi with black and white option which helps reduce the size of the scanned document.**

4. Criteria of eligibility:

The contractor who fulfills the following requirements shall be eligible to apply. Joint ventures are not accepted:

a. Should have satisfactorily completed similar works as mentioned below during the last seven years ending 31st January 2025.

Note: Completion certificate must be attached.

“Similar works means: Electrical Works /Laying of Cable.”

i. Three similar completed works each of value not less than 40% of the estimated cost put to tender

Or,

Two similar completed works, each of value not less than 60% of the estimated cost, put to tender

Or

One similar completed work of value not less than 80% of the estimated cost put to tender.

(Details should be mentioned in Annexure-II)

ii. The value of executed work shall be brought to the current costing level by enhancing the actual value of work at a simple rate @ 7% per annum calculated from the actual date of completion of work up to 31st January 2025.

5. **Average Annual Financial Turnover:** Bidder should have an average Annual Financial Turnover of ₹ 15,00,000.00 (Rupees Fifteen Lakh Only) during the last three consecutive financial years ending 31st March 2024 (Scanned copy of Certificate from CA with Unique Document Identification Number (UDIN) to be uploaded).

6. Earnest Money Deposit:

- a. The EMD amounting to **₹. 59,000.00 (Rs. Fifty-Nine Thousand Only)** shall be deposited in favor of "All India Institute of Medical Sciences, Jodhpur" " payable at Jodhpur, and of any Scheduled Bank the same will be allowed with validity up to 180 days.
- b. The Firms registered with Micro Small Medium Enterprises (MSME) / National Small Industries Corporation (NSIC) / OR Small-Scale Industries (SSI) are exempted from submitting the EMD only (A copy of registration must be provided along with a technical bid). **No other relaxation shall be allowed.** The EMD, in case of unsuccessful Bidders, shall be retained by AIIMS, Jodhpur till the finalization of the tender. No interest will be payable by AIIMS, Jodhpur on the EMD.
- c. *The Hard Copy of original instruments in respect of earnest money deposit must be delivered to the AIIMS, Jodhpur on or before the last date of submission of bid. The bid submitted without EMD will be summarily rejected.*

7. Submission of Tender:

The tender shall be submitted online in two parts, viz., technical bid and financial bid. All the pages of a bid being submitted must be signed and sequentially numbered by the bidder irrespective of nature of the content of the documents before uploading.

✓ **The offers submitted by email or any other media except the CPP portal shall not be considered. No correspondence will be entertained in this matter.**

8. Technical Bid

The following documents are to be furnished by the bidder along with **Technical Bid** as per the tender document:

9. Financial Bid

Price bid Form - Price must be quoted as per the format specified; failing which tender shall be summarily rejected.

General Conditions of Contract

1. The rates shall be quoted only in the schedule of quantities i.e. BoQ separately attached with the tender and nowhere else i.e. letterheads etc. The rates quoted should be inclusive of providing the material at site, all related labour work, making good the area damaged / excavated during the work, all taxes etc. Only GST shall be paid extra as applicable against the TAX invoices.
 2. **The contractor shall bear the cost of supplying the required material at site, laying, termination, jointing with expert jointer for all the existing services being shifted and making good to all the area being damaged during the said work etc. Nothing extra other than the rates quoted will be paid to the contractor in this regard.**
 3. **Validity:** The quoted rates must be valid for **180 days** from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted a validity shorter than the required period, the same will be treated as unresponsive and it may be rejected. In case the tenderer withdraws, modifies, or changes his offer during the validity period, bid is liable to be rejected and the bidders shall not be allowed to quote for any other tender of AIIMS- Jodhpur and the same shall also be intimated to their respective parent department from where they are registered without assigning any reason thereof. The bidder should also be ready to extend the validity, if required, without changing any terms, conditions, etc. of their original tender. In case the last date of sale /, receipt of tender / of opening the tender is declared as a Holiday, the respective dates shall be treated as postponed to the next working day accordingly.
 4. **Technical Evaluation:**
 - a) Detailed technical evaluation shall be carried out by the Institute under conditions in the tender document to determine the substantial responsiveness of each tender. For this clause, the substantially responsive bid conforms to all the eligibility and terms and conditions of the tender without any deviation.
 - b) The Institute's determination of the bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. The Institute shall evaluate the technical bids also to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed, and whether the bids are in order. The Executive Director, AIIMS, Jodhpur shall have the right to accept or reject any or all tenders without assigning any reasons thereof.
 - c) Conditional bids will be treated as unresponsive and will be rejected.
 5. **Financial Evaluation:**

The financial bid shall be opened to only those bidders who are technically eligible. After the evaluation of the bid(s), AIIMS-Jodhpur will award the contract to the lowest evaluated responsive bidder on a **composite basis**
 6. The right to issue and to accept or reject any or all tenders without assigning any reason thereof is reserved by the Competent Authority, AIIMS-Jodhpur.
 7. **Award of Contract:** The Institute shall consider placement of orders for jobs on those bidders whose offers have been found technical and financially acceptable. The Institute reserves the right to counter offer price(s) against price(s) quoted by any bidder.

- 8. Performance bank guarantee:**
- a. Performance guarantee of the contract by all the terms and conditions specified in the tender, the successful tenderer/contractor shall furnish a Performance bank guarantee @7.5% of order value in the form of Fixed Deposit Receipt or Bank Guarantee (as per attached format) from any Nationalized Bank duly pledged in the name of the "All India Institute of Medical Sciences, Jodhpur" after receipt of supply order.
 - b. AIIMS-Jodhpur shall have the right to encash the PBG for non-compliance of any or all the terms and conditions of the tender/contract and to recover any Liquid Damages and penalties under the contract as well as against defects in any of the work as enumerated in the tender/contract.
 - c. **Refund of PBG-** Release of Performance bank guarantee of the work shall be refunded after completion of work and clearance from the Engineer-In-Charge.
- 9. Authority of person signing document:** A person signing the tender form or any documents forming part of the contract on behalf of another shall be deemed to warranty, that he has authority to bind such other and if, on inquiry, it appears that the person so, signing had no authority to do so, the Executive Director, AIIMS, Jodhpur may without prejudice to other Civil and criminal remedies cancel the contract and held the signatory liable for all cost and damages.
- 10. Right of acceptance:** The institute reserves the right to accept the whole or any part or portion of the bid, and the bidder shall provide the same at the rates quoted. The Institute reserves the right to reject any or all tenders /quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained.
- 11. Subletting of Work:** The firm shall not assign or sublet the work/job or any part of it to any other person/party. The tender is not transferable. Only one tender shall be submitted by one bidder.
- 12. Breach of Terms and Conditions:** In case of breach of any terms and conditions as mentioned in the tender, the Competent Authority, will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by AIIMS, Jodhpur in that event the PG shall also stand forfeited.
- 13. Applicable Law:**
- The contractor shall supply the material and executive the work by the relevant CPWD/BIS/PESO norms.
 - The contract shall be governed by laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/ processing.
 - The Arbitration shall be held by the provision of the Arbitration and Conciliations Act, 1996 and the venue of arbitration shall be at Jodhpur. The decision of the Arbitrator shall be final and binding on both the parties. Any disputes are subject to the exclusive jurisdiction of competent court and forum in Jodhpur, Rajasthan, India only.
 - Force Majeure: Any delay due to Force Majeure will not be attributable to the service provider.
- 14.** Payment shall be made only after completion of work on the actual measurement and testing of work done at the site.

15. The quantities are approximate and may increase or decrease as per the actual requirement of work. The contractor shall do the work of the additional quantity upto 1.5 times of contract value AND / OR reduced quantity on the rates quoted in the tender documents. The contractor shall have no claim to any payment or compensation whatsoever on account of any profit advantage or loss which might have been derived from the servicing shall be the actual / ordered / indented quantity.
16. The contractor shall be fully responsible for any damages caused to the Govt. property or allottee's property by his or his labor in carrying out the work and shall be rectified by the contractor at his own cost.
17. **Liquidated Damage:** - If the contractor / Supplier fails to repair/ replace any item damaged/finish the work within 7 days of taking them away from AIIMS- Jodhpur campus, then a penalty @ 1% per week of the total order value shall be levied subject to a maximum of 10% of the total order value.
18. In case of any discrimination, the decision of the Executive Director, AIIMS- Jodhpur shall be final and binding on the bidder/contractor.
