Specifications of Sonicision Hand Probes

1. The following consumables are required for the latest generation cordless ultrasonic energy system.
2. It should be able to provide access to two distinct energy modes with an intuitive single button.
3. Cordless ultrasonic dissector with a tapered curved jaw, Dual mode energy button for energy activation, compatible with Medtronic Ultrasonic dissection Device.
 - a) Shaft length-26 cm, shaft diameter-5mm (Quantity n = 5 box)
 - b) Shaft length-39 cm, shaft diameter-5mm (Quantity n = 5 box)
4. The following products will be provided complimentary with the above consumable items:
 - a) **Reusable Generator:** A Reusable ultrasonic cordless generator for cordless ultrasonic dissection device system, Autoclavable, Reusable – up to 150 sterilization cycles, Integrated LED light for feedback. Make – Medtronic (Quantity = 1)
 - b) **Reusable Battery Pack:** Reusable lithium-ion battery for ultrasonic cordless dissection device system, for usage up to 200 times. Make – Medtronic (Quantity = 2)
