This tender seems to be fixed tender, open for manipulation and not per CVC guideline and it would seem to encourage monopolization and cartelization of the tender because of the following reasons-

1. **Technical Specifications:** The detailed technical specifications against each item of the BOQ have not been given in the tender. Hence the description / specifications are vague and at places not given and can be manipulated to favour some specific brand.
2. **Equivalent makes:** The approved makes specified in the tender are not at par with each technically and commercially which is against the CVC guidelines. A copy of the analysis of rates should be shared with all the vendors.
3. We request you to please add and approve, "Oceanz Acoustic" to increase the competition. The same had been approved by many other government departments for many of their tenders. The copy of NIT's is enclosed herewith for your kind reference and perusal.
