ETN Parts are components, assemblies, or partial products which have had prior usage, but have been duly inspected, reworked, and tested by Intuitive as required so that their function, performance, and appearance will be essentially equivalent to that of new parts.

The da Vinci X Surgical System is subject to the same requirements as devices built only with new components.

SYSTEM TERMS AND CONDITIONS

A signed Sales, License, and Service Agreement ("SLSA") between Intuitive and the Hospital is required prior to shipment of the System(s). All site modifications and preparation are the Customer's responsibility and are to be completed with the specifications given by Intuitive Surgical prior to the installation date. Delivery is subject to credit approval. Payment terms are by irrevocable letter of credit payable draft at sight ("LC"), or by prepayment in full to Intuitive unless otherwise agreed with the Hospital. Ministry of Environment, Forest and Climate Change (MOEF) approval process if applicable, Customs Duty, Custom Clearing Charges and any associated taxes are borne by the Hospital and will be added to the invoice, as appropriate.
